# Human Rights and Children addressed at the 17<sup>th</sup> Informal ASEM Seminar

The 17<sup>th</sup> Informal Asia-Europe Meeting (ASEM) Seminar on Human Rights brought together over 70 experts, professionals, academics, civil society and government officials to discuss the rights of the children, in particular child protection, development and empowerment on 7-8 November 2017 in Sofia, Bulgaria.

In his opening speech the Minister of Labour and Social Policy of Bulgaria, Mr Biser PETKOV, has called for reducing poverty and social exclusion of children, "*The multifaceted dimension of child poverty needs an integrated approach to tackle it, including a synergy of the respective sectoral policies*".

Mr Georg GEORGIEV, Deputy Minister of Foreign Affairs of Bulgaria, highlighted the need "*for a good level of communication among relevant stakeholders - the government on one hand, and the civil society and the international partners on the other hand*".

Mr Henri PLAGNOL, Conseiller d'État of France, called for "*States to systematically promote child-friendly practices specifically nowadays as countries are facing major international challenges*".

Ms Mikiko OTANI, Member of the UN Committee on the Rights of the Child, said in her keynote address: "*the ultimate goal of the whole system of international protection of human rights is to realize human rights of each and every individual at the national level.*" She further elaborated that "*The UN Convention on the Rights of the Child is a powerful tool for the building of the culture of peace through early childhood development preparing children as agents of change for peace and non-violence and recognizing their evolving capacities as active participants in our global village*".

Speaking on behalf of the Asia-Europe Foundation (ASEF), Ambassador Karsten WARNECKE acknowledged "*the exploitation of children as a major challenge for ASEM countries*" and highlighted the need "*for Asia and Europe to seek viable and appropriate solutions through bilateral and regional dialogue to tackle the persistent problem of child rights' abuses*".

The closed-door working groups discussed 3 themes : *International Partnership and State Provision for Survival and Development of*

Children; Protection of Vulnerable Children; Participation and Involvement of Children in Decision-Making. The two main Rapporteurs of the seminar, Prof Ton LIEFAARD, Leiden University and Dr Bina D' COSTA, UNICEF Office of Research - Innocenti, advocated for an interconnected 4 Pillar-Approach of Recognition, Participation, Protection & Empowerment of children's rights.

The Informal ASEM Seminar on Human Rights series is co-organised by the Asia-Europe Foundation (ASEF), the Raoul Wallenberg Institute (nominated by the Swedish Ministry of Foreign Affairs), the French Ministry of Europe and Foreign Affairs, the Philippine Department of Foreign Affairs and the Federal Department of Foreign Affairs of Switzerland (FDFA).
