This will be the largest gathering on human rights between Asia and Europe. The protection and promotion of the human rights of persons with disabilities is the focus of the seminar.

"10 years since the adoption of the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD), people with disabilities continue to face violence and discrimination on a daily basis. The lack of recognition and enjoyment of their human rights affects many aspects of their lives such as education, employment, housing, access to public services and spaces, as well as political participation. Many of these issues will be discussed at length during the seminar in China", said Ambassador Karsten WARNECKE, AEF's Executive Director.

The 3-day meeting, hosted by the People's Republic of China's Ministry of Foreign Affairs, the China Disabled People's Federation, and China University of Political Science and Law, will bring together more than 120 participants, including senior government officials, human rights ambassadors, academics as well as disability experts and advocates from the two regions.

Participants will discuss key concerns and develop policy recommendations for Asian and European decision-makers. The closed-door working group discussions during the seminar will focus on various aspects of the topic including: Participation in Political and Cultural Life; Social and Economic Inclusion; Legal Status, Justice and Remedy; and National Implementation and International Cooperation.

The rapporteurs, Prof. Gerard QUINN, Director of the Centre for Disability Law and Policy of the National University of Ireland (NUI) Galway and Ms LI Xiaomei, Deputy-Director General of the International Department of China Disabled Persons' Federation, will gather key messages, which will then be shared with civil society members and ASEM governments.

About the Informal ASEM Seminar on Human Rights:

The Informal ASEM Seminar on Human Rights series is organised by the Asia-Europe Foundation (AEF), the Raoul Wallenberg Institute, the French Ministry of Foreign Affairs and International Development, the Philippine Department of Foreign Affairs, and the Federal Department of Foreign Affairs of Switzerland. The initiative promotes mutual understanding and cooperation between Asia and Europe in the area of political dialogue, particularly on human rights issues. 
